FEEFHS in FamilyTree Magazine's 101 Best Websites for 2018





The web site <u>WolgaDeutsche.net</u> includes resources for the study of Germans loving in the Volga region of Russia from the late 18th to the present, with information on the history of settlement, repression, deportation, and rehabilitation.

Among other things, the site includes:

- A time line of German settlement in the region from the beginning of settlement to modern times.
- Information on the site's archival document holdings, including images of some documents.
- · A virtual museum and digital photo archive.
- · An interactive map linking to information about Volga colonies.
- · Numerous articles and data files
- A listing of German churches in the Volga region

The <u>Hungarian Archives Portal</u> is an initiative of cooperating local Hungarian governmental archives and the Hungarian National Archives. The portal enables researchers to explore materials found in the archives of Hungary through a unified database, which is continually being expanded. The portal is working toward the digitization of archival records across Hungary.

Collections that may be of interest to genealogists include, but are not limited to:

- Maps
- Registers of names, including voter lists, occupational records, etc.
- Inheritance and chancery cases, including wills, guardianship records, etc.
- Notarial deeds (land records)
- · Civil lawsuits (court records)
- · Criminal procedures and prison registers
- · School registers
- · And much more

The site includes a robust English interface, as well as Hungarian and German.


Save the date for the FEEFHS 2019 Conference!
